While present at OCCA facilities and/or participating in OCCA activities, my child will fully comply with all local, state, and federal laws, regulations, advisories, guidelines, and ordinances. I hereby acknowledge receipt and understanding of the OCCA Rules. My child will fully comply with OCCA rules, regulations, advisories, and guidelines. I further understand that if my child invites and/or allows access to OCCA facilities to any non-member guest or any other individual, I am fully responsible for any loss, damage, or injury that may be sustained by those individuals while present at OCCA property, facilities, or other activities. I further agree to indemnify and hold harmless the Releasee from any loss, liability, damage or cost, including court costs and attorney's fees, that may accrue related to those individuals' presence at or participation in any Releasee facilities or activities.

This instrument shall be binding upon the members of my family, my spouse, and my heirs, assigns and personal representatives. This instrument shall be governed by the laws of the State of Nebraska.
